Greenfield Police Department Report (Chief Johnson): Chief Johnson updated the Commission about developments within the Police Department since he took office, including an excellent staff meeting with nothing but positive feedback. The PD and City have a very busy summer coming up, including Jansen Fest 25 th , Vietnam Moving Wall, Henderson's Ride for Hope, Ethan's Run Against Addiction and participating in a reckless driving initiative with other agencies. In regards to recruitment, there are written examination dates scheduled for early May in order to begin filling positions created with the referendum.

Discussion/Decision to consider reducing recruitment age qualifications for Police Officers, consistent with Wisconsin State Legislature Law Enforcement Standards: We have been losing qualified candidates to other departments due to our age requirements, while other area agencies have a minimum age of 18/20 years old. The Law Enforcement Standards in the State require a minimum age of 18 and a minimum of 60 credits. Chief Johnson and HR Julie Foley recommend lowering the age requirement for sworn officers from 21 years old to 20 years old. Motion by Commissioner Brown to reduce the recruitment age qualifications for Police Officers to 20 years of age, seconded by Commissioner DeGaro. Agreed upon unanimously.
